



DEPUTY MINISTRY OF TOURISM

Plan for providing financial support for the certification of recreational scuba diving service providers in Cyprus (2021 – 2022)

A. GENERAL

- 1. Recreational scuba diving service provider: A natural or legal person who provides scuba diving training services according to the certified training program of the Organisation which authorised such person, or organised guided diving or/and rental of diving equipment. The legal person providing services such as the following:
 - Introductory diving activities;
 - Snorkeling excursions;
 - Provision of training and education;
 - Organized and guided diving for qualified divers;
 - Rental of diving and snorkeling equipment

B. PLAN OBJECTIVES

- The objective of the Plan is to encourage recreational scuba diving service providers that operate in the Republic of Cyprus to become certified to international standard ISO 24803, which specifies the general and specific requirements that should be applied by a recreational scuba diving service provider.
- Applicants that have obtained the certificate (and became beneficiaries of the Plan) shall be featured on the website and all the media of the Deputy Ministry of Tourism and shall be invited in priority to the booths of diving tourism exhibitions, in which the Deputy Ministry of Tourism shall participate.

C. BENEFICIARIES

Beneficiaries of the plan are the Recreational Scuba Diving Service Providers pursuant to the definition of paragraph A.1.





D. APPLICATION

- The final date for submission of applications is set to be the 31st of December each year or until the maximum of the appropriations regarding the Incentive Plan of the budget of the Deputy Ministry of Tourism has been reached. All requests should be submitted using the relevant Form 1 "Application for the support of Certification under the standard ISO 24803 which is attached.
- 2. A letter of a Certification Company which confirms that the applicant has commenced the certification process in line with the standard.
- 3. A certification of an internationally recognized Organisation, according to the list in Annex 1, attesting that the provider follows the certified scuba diver training program, that was created by that particular organisation.
- 4. The Articles of Association of the company, certified by the Registrar of Companies, which confirms the nature of the company's business.
- 5. The requests may ONLY be submitted via e-mail to the e-mail address cpapachristodoulou@visitcyprus.com. The responsibility for the receipt of the requests rests on the applicant's shoulders. E. THE LEVEL OF FINANCIAL SUPPORT

The level of the financial support is fixed at maximum €600 per recreational scuba diving service provider, per year of certification for acquiring the certification in line with the standard ISO 24803, for the first, second and third year of certification, with subject to the available appropriations. Each diving service provider may be granted an aid from this Plan for three years (from the date of acquisition of the certification), while the Deputy Ministry of Tourism is not bound in any way to the continuation of the Plan in question.





F. APPLICATION ASSESSMENT PROCESS

The applications shall be assessed based on the order in which they were submitted to the Deputy Ministry of Tourism and until the maximum of the appropriations has been reached.

G. TERMS AND GRANT PAYMENT PROCESS

- 1. The beneficiaries should submit the following documents so as to receive payment of the approved amount of support:
 - (1) A tax invoice sent by the beneficiary to the Deputy Ministry of Tourism, which will state the same of the recreational scuba diving service provider and the amount of support that has been approved.
 - (2) A copy of the ISO 24803 certification by the Certification Body.
 - (3) A copy of the receipt of a Certification Body for the amount paid for the acquisition of the certification in line with ISO 24803.

H. VALIDITY OF THE PLAN

The Plan shall be valid on an annual basis until the 31st of December of each year or until the maximum of the appropriations has been reached. Unless the Deputy Ministry of Tourism decides otherwise, the Plan shall be automatically renewed for the following year.
